| General Terms: | 1. _____ (mare owner) have hereby reserved one breeding to Metallic Heaven , AQHA Registration #5789619 (HERDA: HRD/N) for the Mare _____, Reg. # _____, for the Breeding Fee of \$1,600.00 . (Made payable to Jeri Slover) during the 2026 breeding season, March 30, thru July 31, 2026 and will include the first shipment , of cooled semen. A Non-Refundable booking fee of \$300 will be due when returning signed contract (booking fee will be deducted from breeding fee). This contract is non-transferable nor assignable without consent from Jeri Slover. Contracts that are not paid in full by July 15th of 2026 will be cancelled. |
| Chute Fee: | This breeding includes the Chute Fee. If for any reason, more than one collection is needed, \$475.00 will be charged for each additional shipment. |
| Donated Breedings: | Mare owners with donated breedings or stallion auction winners, will pay Chute Fee of \$550.00 for first shipment. If additional collections are needed, \$475.00 will be charged, for each additional shipment. |

Orders for semen must be called in to Jeri Slover at 307-899-5374. Stallion is collected early mornings Monday, Wednesday and Friday. Please request 24 hrs prior, if possible, and no later that 5:00 pm the night before, to collect.

Shipped Semen

1. Semen is shipped in viable condition and Jeri Slover shall not be held liable for contamination of semen during and after shipment, loss of viability, or any costs arising from shipment delayed, damaged or lost in transit. We agree to process each ejaculate to optimise 24-hour post cool motility and subsequent fertility.
2. FedEx Priority Overnight shipment is included in the chute fee and the first shipment is included in contract fee. Chute fee must be paid before semen leaves the ranch. Any subsequent pickups, shipments, and deliveries must be paid in advance, or can be charged on the credit card on file. Mare owner is responsible for pick up or costs associated with pick up.
3. Stallions are collected on Monday/Wednesday/Friday- March 30- July 2nd, 2026. It is the responsibility of the mare owner and his/her veterinarian to confirm our breeding days. Semen must be requested the day prior to collection, by 5:00 PM MST, by contacting Jeri Slover at 307-899-5374. Requests must be confirmed verbally.
4. Shipping containers must be returned in a timely manner. If container is not returned in one week, \$50 will be charged to mare owner.

Foal

1. Live Foal Guarantee: Your foal will stand and nurse without assistance. It is understood that if the mare proves barren, aborts her foal, or if foal is born stillborn, a return breeding will be guaranteed the following year only, providing the notification is received within 7 days of the occurrence. A live foal guarantee will apply to those mares that are certified in foal by a licensed veterinarian. Confirmation must be sent to Jeri Slover in order to guarantee a rebreed. Confirmation can be in the form of a letter from an attending licensed veterinarian. Stallion owner does not make any warranty or guarantee as to the foal will be free of any infirmity, conformation defect, disease or inherited trait.
2. Mare owner shall notify Jeri Slover of pregnancy status within 35 days of insemination. Failure to contact by Oct 15th will result in a \$50 late fee to add the mare to the Stallion Breeding Report.
3. To register the foal, you must notify Jeri Slover of the birth of the foal. This certificate will not be issued nor released until the account has been paid in full.

Rebreeds and Embryo Transfers

1. If the mare does not produce a live foal the first breeding season, the mare owner is entitled to rebreed the following year. Mare owner will pay the additional Chute Fee. If the mare owner fails to return the mare for breeding the following year, then any and all fees paid shall be forfeited, the right to rebreed is cancelled and the stallion owner is released from all further obligation of the contract, unless otherwise agreed to in writing and signed by the stallion owner and the mare owner. All third year rebreeds are at the sole discretion of the stallion owner.
2. Embryo transfers must be reported to stallion owner. In the event of multiple embryos, from a single flush, mare owner agrees to notify Jeri Slover once the additional recipient mares have been confirmed in foal with a heartbeat present. The mare owner must then pay the Stallion Fee equal to the aforementioned Stallion Fee for each additional live foal. The additional Stallion Fee is due upon the additional foal(s), standing and nursing. Additional Breeders Certificates will be issued upon the receipt of necessary Stallion Fees.

Should Metallic Heaven die or become unfit for service for any reason, then this contract shall become null and void, and both parties are relieved of any further obligation hereunder. Any monies paid by the mare owner toward the Stallion Fee shall be refunded.

Mare Owner Agreement

1. Mare owner agrees that the mare presented for breeding will be in good health and in sound breeding condition. Any mare certified by the attending veterinarian to not be in sound breeding condition shall not be bred and another mare may be substituted after submitting HERDA genetic results and found to be N/N, at no additional cost.
2. Nothing shall be posted or shared via social media that could be negatively construed regarding Jeri Slover or Metallic Heaven, nor any of its employees, associates or affiliates. Any concerns or question need will be addressed to Jeri Slover. Customer service is a top priority. Failure to do so may result in legal action regarding the content and damages associated from such action. Furthermore, Jeri Slover reserves the right to void this contract in the event this Agreement is breached. Any offending mare owner shall immediately forfeit any fees, payment or right to a rebreed.
3. Mare owner acknowledges that Metallic Heaven has been tested as a carrier for Hereditary Equine Regional Dermal Asthenia "HERDA". Best practice, with equine breeding, includes disease testing all breeding stock. Mare owners assume all responsibility of compatible breeding and stallion owner will not be held responsible for affected foals as the stallion's disease panel has been declared.

This Contract

1. This contract is a binding agreement between Stallion Owner and Mare Owner and is non-transferrable, unless otherwise agreed to, stated in writing, and signed by Stallion Owner and Mare Owner. Any transferred breedings will incur an additional Chute Fee. Completed paperwork, to include contract information, must be submitted by the new contract holder.
2. This contract is valid for the 2026 breeding season only. Mare owners may not purchase this contract with the intent to use in a subsequent season. In the event of this contract being paid in full, and the mare never being bred, this shall become a rebreed for the following season only.
3. When the mare owner signs and returns this contract to the Stallion Owner, it becomes a valid binding contract upon both parties.
